Strolling through the halls of Meeting Street's beautiful new home in Providence, you get the feeling that we've been here forever. That's because we took all the best of what Meeting Street has always offered and combined it with a state-of-the-art facility to create an exceptional place of learning for children of all abilities. Even as yards of packing tapes trailed through the hallways and moving boxes filled every room, we always knew we were home. Our location had changed but our rich traditions, compassion and commitment to every child remained intact.

That was never clearer to us than on that blustery day in January 2007 as 23 buses from throughout Rhode Island and southeastern New England rolled up to our front door for the very first time. And while their school was new, the friendly face that greeted and welcomed each child was the same.

That very day, just down the hall from the main entrance, our librarian, and music and art teachers were planning Meeting Street's monthly music series, which brings local and national artists and musicians to our campus to perform for our students and the community. This great experience was made possible with support from VSA Arts of Rhode Island and Rhode Island State Council on the Arts.

That same day, teams of early childhood professionals from our Early Intervention program prepared for their daily road trips. The largest provider of early intervention services for children (birth to age 3) in Rhode Island, our teams of experts conduct developmental and physical assessments and treatment plans for more than 600 families in the community each month – and they do most of this in our families' homes.

Around the corner and right next to the therapeutic pool in the CVS Caremark Charitable Trust Gym, The Grace School's fully inclusive first grade class was getting ready for a workout. What is amazing is that the children in this class, which is made up of children with and without special needs, do not see each other as having any differences. They see friends and classmates who are learning and thriving together in the Meeting Street community. Our commitment to inclusion continues to grow each year, and we are excited about our plans to open our first fully inclusive 2nd grade classroom in September 2008.

As we continue **reaching, growing and thriving**, I hope you realize how much we appreciate and count on your continued support to make all of this possible for the over 3,000 children and families that we serve each year. Thank you and warm wishes for 2008!
