2022 FFAC Liability Waiver and Release of Claims

In order to qualify as a registered participant in the Fishing for a Cause charity fishing tournament, organized by and for the benefit of Meeting Street Massachusetts, Inc. (hereinafter "Meeting Street"), taking place on Friday, June 10 to Saturday, June 11, 2022, I acknowledge and agree to the following:

1. The risk of injury, disability, death, loss or damage to person or property from the activities involved in fishing tournaments is significant, including the potential for permanent/partial disability, paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist;
2. I have been advised by Meeting Street, and have had the opportunity to seek legal counsel with respect to the legal effect of this document; and, I KNOWINGLY AND FREELY ASSUME ALL RISKS REFERRED TO ABOVE, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES (AS DEFINED BELOW) OR OTHERS, AND ASSUME FULL RESPONSIBILITY FOR RISKS ARISING FROM MY PARTICIPATION IN THE FISHING TOURNAMENT;
3. I willingly agree to comply with the terms and conditions for participation. If, however, I observe any unusual significant hazard(s) in my presence or during participation, I will remove myself from participation and bring such to the attention of the nearest official immediately;
4. I, FOR MYSELF AND ON BEHALF OF MY HEIRS, ASSIGNEES, PERSONAL REPRESENTATIVES AND NEXT OF KIN, HEREBY RELEASE, DEFEND, INDEMNIFY AND HOLD HARMLESS MEETING STREET, ITS AFFILIATED COMPANIES, THE OFFICERS, OFFICIALS, DIRECTORS, AGENTS, AND/OR EMPLOYEES OF EACH, OTHER PARTICIPANTS, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, VOLUNTEERS, AND, IF APPLICABLE, OWNERS AND LESSORS OF PREMISES AND PROPERTY USED TO CONDUCT THE EVENT ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSON OR PROPERTY, WHICH I SUFFER OR WHICH I AM FOUND TO HAVE CAUSED IN WHOLE OR IN PART BY MY NEGLIGENCE OR INTENTIONAL MISCONDUCT, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES, OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW;
5. I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT AND THE ATTACHED RULES, FULLY UNDERSTAND THEIR TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY; and

In consideration for permission to participate in the fishing tournament, I hereby grant fishing tournament organizers and Meeting Street, its assignees and/or licensees (including television production companies contracted by fishing tournament organizers), the unconditional right to use my name, voice, photographic likeness, biographical information, fishing tips and/or instructions in any medium whatsoever, including but not limited to video/audio productions, merchandising, promotions, articles, and/or press releases, in connection with Fishing for a Cause and/or Meeting Street, without restriction as to changes or alterations at any time. I understand that I will not be entitled to receive any royalties or other compensation in connection with such use and waive my right to review the finished product.
