The Power of Early Intervention

Luca's Story

When Francesca Savella and Daniel Levasseur became parents for the first time, they were overjoyed – and, before long, quietly worried. Francesca had a gut feeling that Luca wasn't hitting his developmental milestones; however, and as first-time parents, they weren't sure what that meant or where to turn.



"We were as green as could be," Daniel recalls. "We didn't have anything to go on." Their pediatrician pointed them to Meeting Street's Early Intervention (EI) program, and Luca, just over two years old, began working with Occupational Therapist Julia Caristi and a developmental educator. With EI services ending at age three, the window was narrow – but this family didn't waste a moment.



"This family climbed the wall," Julia says. "They wanted to achieve every single goal on their list, and they did." The progress was fast and, for Francesca, deeply emotional. Using co-regulation techniques, Luca learned to work through the tantrums and hurdles that had once felt impossible. The team would arrive for sessions to find Francesca in happy tears. "He did it!" she would tell them.

That kind of breakthrough is exactly what Early Intervention is designed to make possible – and what your support helps fund.

For families like Luca's, the program isn't just a service, it's the difference between being stuck and moving forward.

"When it all clicks, it can really benefit your child and your family," Francesca says. "We've experienced that first-hand." Luca didn't just meet his goals, he exceeded them. And he didn't do it alone.

Birth to age three are the most critical years of development in a child's life, which is why Meeting Street's Early Learning Center (ELC) exists! Located on our 12-acre Providence campus, the ELC partners with families to help their child develop, grow and learn in a safe, nurturing and engaging environment. The ELC has a 4-star rating from BrightStars, Rhode Island's quality assessment tool, and accepts RI child care vouchers, helping all families access high-quality early childhood education for their child.

What makes our ELC different?

- **Inclusive Classrooms**

When students with and without special needs learn in the same environment each day, community is formed, compassion is built and difference is cherished. Scan the code to hear the heartwarming story of how Oliver's classmates wanted to learn "Ollie's language" when given the chance to explore.



- **Staff Qualifications**

Beyond the inclusion model, what makes our ELC unique is the qualifications of our staff. Each classroom teacher has a bachelor's degree in early childhood education, or a related field. Our teacher assistants have an associate's degree or 12 college credits in early childhood education. And did we mention our staff includes a registered nurse?

- **Newly Constructed Space**

Not only is our ELC new, it includes spaces that you won't find in other centers, like a Sensory Integration Gym that helps students self-regulate, and our multi-lingual and multi-modal Young Learners Library that ensures every child has a story they can understand and enjoy.

Meeting Street is undertaking a significant expansion of The Schwartz School campus, including the construction of a new, purpose-built school building designed to serve students with special needs from communities across Massachusetts.

A Campus Built to Celebrate Every Child

Spanning approximately 30,000 square feet, this single-story building will foster learning, independence, and the growth of our student community. Enhancements to the surrounding campus are also planned to complement the new building.

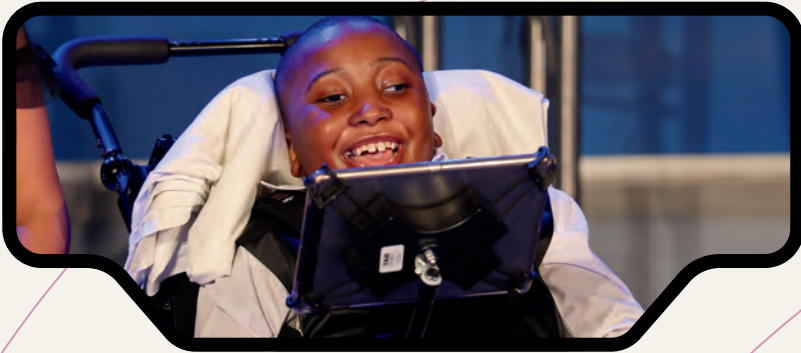
